Decision-Making Process

- Consider county-level data to determine MDE's recommended Base Learning Model
- Consult with health officials to examine local data and consider impact on schools
- Evaluate our district's ability to implement required and recommended protocols (ie. staffing, transportation, supplies, protocols, physical distancing)
- 4. Determine the learning model to begin the school year
- Monitor community and school-level impact of COVID on a regular basis and adjust if needed


Moving Between Learning Models

The COVID-19 pandemic is changing the way we do school. Our goal for the 2020-2021 school year is to safely restart learning and reconnect with our students.

It is very likely that we will have to change our learning format throughout the year - sometimes meeting In person full-time or in a hybrid model and sometimes moving ALL students to distance learning - depending on the prevalence of COVID-19 in our community.

Whether learning in person or from home — all instruction this year will be developed in an online format so we are able to respond to changing circumstances and move quickly between models.

Families and staff will need to be flexible and have alternative plans should we move to in-person, hybrid or distance learning district-wide or at an individual school or classroom level.







Learning
"On The Dial"

In-Person Learning

Students would return to school full time for in-person learning

Hybrid: Blended Learning

Students would spend 2 days of the week at school learning in person and 3 days at home learning online

Alternating schedule of A/B/A/B/C

Distance Learning

Students would learn from home with the support of district teachers through the use of technology

OR

Families who are not comfortable returning to school may choose to enroll in 100% Online Learning

In-Person Learning

- Students will attend school full time
- Schools will follow all safety protocols and guidelines for face coverings and cleaning and sanitizing
- No large events or assemblies will be held and modifications may be made to the school day to limit the number of students in one area at a time, such as lunch, recess, dismissal times, etc.

Families and staff must be flexible!

There will likely be times during the year when all students will be moved to either Hybrid or Online Learning due to COVID outbreaks in classrooms or buildings.

Those not comfortable with in-person learning can also opt-in to online learning full-time.



Hybrid Learning

- Students in "Group A" will attend school Monday and Wednesday while "Group B" is learning from home, and then they'll switch on Tuesday and Thursday. "C" days will be a distance learning day for all students so buildings can be cleaned, and teachers can make personal connections with students and collaborate with colleagues.
- Schools will follow all safety protocols and guidelines for face coverings, physical distancing, and cleaning and sanitizing, and will operate at about 50% of capacity both in schools and on buses
- Priority will be to schedule families together on same days

There will likely be times during the year when all students will be moved to Distance Learning due to COVID outbreaks in classrooms or buildings, or to In-Person Learning if it is safe to do so.

Those not comfortable with in-person learning can opt-in to 100% Online Learning.

Distance Learning



We've learned a lot since this past spring and are making significant changes from distance learning:

- Recorded mini-lessons to introduce learning
- Teacher interaction with students one-on-one and in small groups
- Mix of scheduled learning times as a class along with independent online learning
- Peer-to-peer activities to provide more social/emotional support
- Streamlined communication and more consistent use of apps and platforms

Definitions:

- Asynchronous: Students learn the same material at different times and locations
- Synchronous: Students learn at the same time by connecting virtually with their teacher and peers

Families and staff must be flexible!

In the event of a COVID outbreak in a classroom or a building, ALL students may be moved to Distance Learning.

Families not comfortable with any type of in-person learning can also opt-in to 100% Online Learning.

100% Online Learning

Families not comfortable with any type of in-person learning can opt-in to the 100% Online Learning, which features:

- A consistent schedule of at-home learning
- Teacher interaction with students one-on-one and in small groups
- Mix of scheduled learning times as a class along (synchronous learning) with independent online learning (asynchronous learning)
- Peer-to-peer activities to provide more social/emotional support
- Streamlined communication and more consistent use of apps and platforms

In-Person/Hybrid/Distance Learning:

- Students will follow their assigned schedule
- Families and staff will meet to discuss and agree to a set of prioritized services to be delivered in-person, when possible. Other services will continue remotely as specified in the Individualized Education Plan (IEP) or Individualized Family Service Plan (IFSP)
- Services for students with complex health or support needs will be addressed in collaboration with families on an



100% Online Learning:

- Students will be provided their special education services and supports from home as outlined in their individualized distance learning plan as developed in collaboration with families on an individual basis
- This option supports students and families with a variety of medical concerns or those who just don't feel comfortable returning to school yet

4-Year-Old Preschool

- Preschool will follow the same schedule as our elementary schools for both In-Person and Hybrid Learning
- There will not be an Online Learning option for preschool families
- Depending on space availability, Preschool Play Days may be available for families seeking on option on the days when school is not in session
- ThreeSchool preschool programming will remain the same during In-Person and Hybrid Learning
- Preschool is a fee-based program
- Special education case managers will be communicating with individual families on their child's special education services during the hybrid model with online learning as an option for special education service delivery

Supporting Students and Families

- All learning models will focus on relationships and building positive connections with staff and classmates
- School counseling, mental health supports and resources will be available for all students, whether enrolled in In-Person/Hybrid/Distance or 100% Online Learning
- Staff will be available to support families with technology needs
- We're developing plans to provide orientation (WEB and Link Crew) to our 6th grade and 9th grade students either virtually or in-person
- We'll be providing Ready, Set, Go (RSG) Conferences for all elementary students and families
- We're also developing ways to build strong connections between teachers and students, should we need to start the year in either a hybrid or online model

School Age Care - Adventure Club

- Executive Order 20-82 indicates that the district must provide care for children
 of Tier 1- essential workers at no cost during the school day for kindergarten to
 age 12 children at times when the district is operating in a hybrid or distance
 learning model.
- We will do our best to provide a fee-based childcare program for families not classified a Tier 1 essential workers and before and after school based on:
 - Available space in our schools
 - Available staff

Safety Protocols

- We follow all CDC and MDH protocols
- Physical distancing of individuals in classrooms and common areas, and visual reminders for physical distancing
- Face coverings for all students (K-12+) and adults in our buildings
- Regular handwashing of students and staff; handwashing stations with soap and/or hand sanitizer in each classroom
- Limited sharing of supplies
- Increased daily and weekly enhanced cleaning and disinfecting
- Increased circulation of outside air into buildings



Screening Expectations







Families, students and staff are expected to self screen at home before coming to school:

- Children and staff should be screened daily for any symptoms of COVID-19 including:
 - O New onset of cough
 - O Shortness of breath
 - O Fever of 100.0 degrees or higher
 - O Chills
 - O Muscle pain
 - O Sore throat
 - O Loss of sense of smell or taste
 - O Gastrointestinal symptoms of diarrhea, vomiting, or nausea

Anyone experiencing

ANY of these symptoms should not attend school

Transportation

- Bus capacity will be at 50%, as defined by MDE/MDH
- Students, drivers and bus aides are required to wear face coverings/masks
- Students will be one to a seat and those from the same household may sit together
- Seats will be assigned
- Bus pick-up areas at each school will be marked for physical distancing
- Individualized Education Plan (IEP)-driven accommodations will be reviewed with a commitment to finding solutions for all families of children with special needs
- Cleaning and disinfecting will take place following each route with special attention to high touch areas
- Bus and parent drop-off and pick-up zones and loading/unloading times may need to be modified.
 Specific instruction will come from your child's school

School Meals

In-Person/Hybrid schedules

- Breakfast and lunch will be available to students when they are in school
- Meals will also be available to students for days they are learning from home

Distance & Online Learning

 Weekly meal distribution will be available for families choosing 100% Online Learning, as well as for all families when in a Distance Learning model

Meals served at school:

- Students may eat meals in small group settings outside of the cafeteria, including classroom spaces, as determined by the school sites
- Students will wash hands before and after meals

Have I Been Exposed?

Closer than 6 feet




For longer than 15 minutes



Possible exposure

You will be notified by school staff if you've been exposed and need to stay home



- Stay home for at least 10 DAYS since symptoms began AND until no fever for at least 3 DAYS without medication AND improvement of other symptoms
- Siblings and household members stay home for 14 DAYS
- Other staff and students exposed to the individual will also stay home/quarantine for 14 DAYS

When There Is a COVID Case In a School

WE WILL

Communicate to all families in a school when there is a positive case (staff or student). Conduct extra cleaning in areas where the infected person spent time. Continue to provide important health information to families. Contact all students and/or staff who were in close contact with a person who has a confirmed case of COVID-19. Monitor symptoms of students and staff. Send students and staff home if they become ill at school.

WE WILL NOT

Provide personally identifiable information of an infected person.

Immediately close schools for one positive case.



Athletics/Co-Curricular/Extra-Curricular Clubs

- We follow all Minnesota Department of Health (MDH), Minnesota State High School League (MSHSL), and National Federation of State High School Associations (NFHS) standards for a return to play protocol
- A decision on the status of fall sports is expected to be announced by the MSHSL in mid-August

Community Education Classes

- Community Ed classes will be held online and in-person provided the number of participants can be physically distanced and no other state or local restrictions are in place.
- Depending on space availability, offerings may be limited.
- Face coverings/masks are required indoors; except when physical distancing is possible and at times when the activity requires the participant to exert themselves.
- As much as possible, participants will have individual supplies.
- Participants and instructors must follow all self screening expectations.

Pony Activity Center (PAC)

- The number of members allowed to work out at any given time will be restricted based on local data from public health.
- Members must follow all self screening expectations.
- Face covering may be removed at the PAC while the level of exertion makes it difficult to wear a face covering, provided that social distancing can be maintained.
- Members are expected to follow all equipment cleaning protocols.
